Financial Report

The treasurer, Bre Wand, presented the Treasurer Report. Account balance on 5/13/2024 \$90,931.49. The account balance on 1/24/2024 is \$55,593.65. Total income was \$73,476.30 and total expenses were \$38,138.46. \$32,234 was the estimated profit from the Panther Run. We met 90% of our school wide goal. The money has been allocated for logo rugs, poster printers, and programs and assemblies as voted on in the last general meeting. Treasurer Report was filed.

2024-2025 Board Member Nominations and Voting

President Nominees Jessica Pavelchak and Nicole Ribelin gave 2-minute speeches and 30 members in attendance voted. Andie motioned for the ballots to be destroyed once tallied. Motion carried.
